

#### **Climate and Nature**

Fedrigoni is committed to contributing our part to the Paris Climate Agreement target of limiting global temperature increase to well below 2°C above pre-industrial levels by significantly reducing our carbon emissions by 2030 and achieving net-zero carbon emissions by 2050.

Beyond carbon, we are also committing to a more holistic vision of our impact on nature. Fedrigoni makes sure that paper and paper products are manufactured in compliance with main international regulations related to dangerous substances (e.g., Regulation EC n. 1907/2006 REACH), in particular without chlorine (using TCF and/or ECF pulp) and is committed to prevent and avoid the use of all hazardous substances from its processes and products. We are setting targets to improve our water-use efficiency and water-quality treatment, reduce waste, and conserve biodiversity within our operations and supply chain. All these actions are aligned with the European Union Deforestation Regulation (EUDR), Kunming-Montreal Global Biodiversity Framework, and the Global Goal for Nature

frameworks which seek to eliminate nature loss from 2020, make a positive impact on nature by 2030, and enable full nature recovery by 2050.

The International Day for Biological Diversity gives us an excellent opportunity to regularly organize activities to raise awareness and sensibilize our community about the importance of this issue.
